

Striking It Rich In Las Vegas Contest - DEFINITIONS

Grand Prize – \$1,500.00 towards a trip to Las Vegas, Nevada for a maximum of two individuals.

Grand prize Winner – The 1st name drawn for the *Striking It Rich in Las Vegas* contest.

Secondary Prizes & Winners – The 2nd name drawn (\$300.00 Pro Shop gift certificate) & 3rd name drawn (\$100 Pro Shop gift certificate).

Associations – Manitoba Tenpin Federation, Brandon Tenpin Bowling Association, Dauphin Tenpin Association, Winnipeg Tenpin Bowling Association, Manitoba Bowling Association & their board members, employees & agents.

Adult Bowler - A 21 years of age (as of September 1, 2015) Canadian Tenpin Federation registered member with permanent residency in Manitoba.

Sanctioned Tournament – A Canadian Tenpin Federation Bowling Tournament sanctioned by and hosted by one or more of the *Associations during the 2015-16 season*. (see list of applicable tournaments – SECTION B).

Tenpin Bowling Community – Includes any Canadian Tenpin Federation registered member, their family or friends; Association employees, board members, agents; any individual, owner, employee, agent or family members of any business affiliated with the sport of tenpin bowling.

Recognized Manitoba Tenpin Bowling Pro Shop
– (See List – SECTION C).

This Free Draw is open to **all Adult Bowlers that are 2015-16 Manitoba Canadian Tenpin Federation Registered Participants**, including all Association board members that are **21 years of age as of September 1, 2015**, that participate in any & all Sanctioned Tournaments as defined above and listed below in Section B. **One entry will be awarded for each and every paid entry per tournament event** (ie. Singles, Doubles &/ or Team). In tournaments that offer all three events, a **Bonus entry** will also be awarded if the participant enters all three different events in the same tournament.

All Manitoba Tenpin Federation employees are not eligible to enter.

All Grand Prize bookings are to be done through Algonquin Travel and subject to existing availability. Bookings are also subject to all rules and regulations of the applicable airline, hotel/resort and/or Algonquin Travel.

The Grand Prize bookings are subject to availability, changes in itinerary and other restrictions. **Trip cannot be modified by winner after confirmation** booking with Algonquin Travel.

All Grand Prize & Secondary Prize Winners **must accept their prize as awarded**, in accordance with the stated rules.

The Grand Prize Travel Certificate may be used towards airfare, accommodation and related services, taxes and fees at time of booking for the Grand Prize Winner and their guest.

The decisions of Manitoba Tenpin Federation's Executive Director are final and binding, without right of appeal, with respect to all aspects of the draw(s) (including without limitation eligibility and/or disqualification of entries) and entrant agrees to abide by the draw rules and all of the instructions and decisions of the Manitoba Tenpin Federation and/or members of the MTF board.

In the event of any dispute regarding the interpretation of these rules, the decisions or interpretation of the Manitoba Tenpin Federation's Executive Director shall prevail.

All entries become the property of Manitoba Tenpin Federation. Any entry that is late, incomplete, altered, or contains false information, is invalid. The Associations are not responsible for lost, stolen, delayed, damaged, or misdirected claims or entries or for any problems or technical malfunctions during the Draw Period. The Associations are not responsible for any errors or omissions with respect to the tabulation, printing or advertising of this draw and reserves the right to withdraw, amend or cancel this draw in the event of a printing or administrative error.

 as teams (highest youth average with lowest adult average, and so on) and compete on
 a handicapped score basis.
Jan 31, **Ladies 600 Club Tournament** - By invitation only. Run in conjunction with the joint
 WTBA/MBA
Feb 6-7 **Annual Tournament.**

Winnipeg Tenpin Bowling Association:

- Oct 3 **Mystery Handicap Mixed Tournament** - Format to be determined
- Oct 18 **Hi-Lo Doubles** – Now has both Women's and Men's Divisions. Qualify thru league – highest average paired with lowest average – Handicap tournament
- Nov 14 **179&Under Mixed Handicap Singles** – Open to all bowlers with averages of 179 or less.
- Nov 28 **Tournament of Champions** – Hdcp Singles – Men and Women with highest average in their league from previous season qualify (i.e. this means there will be 2 entries from each Mixed league).
- Dec 13 **Jeanne Stear Singles** – Hdcp – Qualify thru your league by improving your average the most during the qualifying period – ask your league secretary for the details
- Jan 16 **Allan Boes Singles** – Handicap, open to all sanctioned men and women bowlers.
- Jan 30 **5-Division Scratch** – Singles event; 4 games – open to Men and Women. You compete against bowlers in your average classification. New format includes the ability to discard your lowest game
- Jan 31, Feb 6-7 **WTBA/MBA Annual** – *NEW* - This is now one joint WTBA/MBA tournament (it was previously two separate tournaments), being run on 3 days over two weekends. Men, Women, Mixed; singles, doubles, team events, both scratch & handicap
- Mar 5-6 **Marinelli City Singles** – Men's scratch singles event – Day 1 is 8 games of qualifying, and the top 16 advance to Day 2 finals
- Mar 20 **A&H "Strike Out Cancer" Doubles** – Now includes both Men and Women. Hdcp event. Has your average improved the most in your league during the qualifying period? Then you may qualify to represent your league. Ask your league secretary.
- Apr 10 **200-Club Tournament** – By invitation only - **Women** who have bowled a 200 game or better in sanctioned league or tournament play in the current or any previous seasons are invited to this tournament.
- Apr 10 **200-Club Tournament** – By invitation only - **Men** who have bowled a 200 game or better in sanctioned league or tournament play in the current or any previous seasons are invited to this tournament.
- Apr 16-17 **Eric Young Memorial Championship** (formerly Trophy House) – Team event; handicap. Qualify thru your league during the 4-week qualifying period. A fun event! Ask your secretary for details!
